

Terms and Conditions

Agreement between User and pto-poker.com

Welcome to pto-poker.com. The pto-poker.com website (the "Site") is comprised of various web pages operated by PTO Poker ("PTO Poker"). pto-poker.com is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the "Terms"). Your use of pto-poker.com constitutes your agreement to all such Terms. Please read these terms carefully, and keep a copy of them for your reference.

pto-poker.com is an E-Commerce Site.

PTO Poker is an educational coaching site. It is a hybrid of poker strategy education, performance optimization, and mindset coaching. PTO Poker is NOT a site that runs online poker games. The PTO Poker content is purely instructional.
